#### **Abstract**

This paper offers a critical analysis of the prevailing themes and literature devices in the chosen novels of Kiran Desai, hullabaloo in the guava orchard (1998) and The Inheritance of Loss (2006), and puts her works in the context of postcolonial Indian-English and global diasporic literature. Basic tools that generate sensory effect and layers of meaning are metaphors, similes, and vivid images. They are emotional, represent abstract ideas and enhance the involvement of the reader as it makes descriptions more evocative and memorable (Leddy, 2025)<sup>[17]</sup>.

# Tone (satirical, lyrical, ironic etc.)

Tone defines how the reader feels about the story and what the reader perceives of the story. Satirical mood is a derisive and critical attitude to social conventions; lyrical mood is poetic and musical, in which the beauty or the emotion is described; ironic mood refers to the discrepancies between appearance and reality, which tends to emphasize more fundamental social or psychological truths (Glatch, 2025) [12].

# Symbolism, Motifs, and Allegory

Symbolism involves applying objects, characters or events to convey larger ideas or themes that are not limited to their literal interpretation. ## Conclusion

The critical review of Hullabaloo in the Guava Orchard and The Inheritance of Loss by Kiran Desai shows how her fiction is an intricate intertwining of personal, cultural and
